Staff Recomm. (Full):								
Comments:	 The applicant has proposed changing the street name of Burge Avenue to Elston Turner Drive to honor a Knoxville native whose accomplishments and contributions to the community have been exemplary. Burge Avenue has been demolished and is being rebuilt in a slightly different configuration inside the Austin Homes Development (see Exhibit A). Any property using this right-of-way for access will be readdressed with the new street name. Addressing staff has noted that the proposed name change will require roughly 100 address reassignments. However, these addresses correlate to newly constructed apartments that are currently unoccupied, so any needed address changes should not create undue impact for residents. City Inspections may have to revise permits that have already been issued. Addressing staff has approved the proposed street name and all abutting property owners have signed the petition in favor of the change. Staff has received no objections to the renaming of this right-of-way. It meets all requirements of the "Addressing Guidelines and Procedures" section of Knoxville-Knox County's Administrative Rules and Procedures as well as those in the City of Knoxville's Code of Ordinances, Chapter 23, Article IV, Section 23-108.
