This proposal is to rename the section of Andes Road to Ball Road starting from the new terminus at Schaad Road to the northeast corner of parcel 091PA037 (see the blue segment encircled in purple in Exhibit B). This name change complies with the Knox County Uniform Street Naming and Addressing Ordinance, to ensure there are no non-contiguous streets. 3. Addressing staff coordinated with Knox County Engineering and Public Works to determine appropriate street names for these segments based on the logical extension to connecting streets. 4. The proposed street name change from Andes Road to Ball Road will require four addresses to be assigned. 5. Planning has received no objections to the renaming of the right-of-way. 6.
