Comments: The Tennessee Legislature recently enacted a law that impacts MPC's public notice requirements. This

amendment to the Administrative Rules will bring the local public notice rules in line with those required by the state legislation. The effect of this amendment is that will require that the General Plan and all elements of that plan such as the sector plans and Knoxville One Year Plan prior to appearing on MPC's monthly agenda be advertized in the pulic notice section of the newspaper at least 30 days prior their consideration. A thirty day public notice will also be required between the MPC's consideration of those matters and the public hearing by the Knoxville City Council or the Knox County Commission.
