Comments: NEED AND JUSTIFICATION FOR THE PROPOSAL

1. The proposed One Year Plan amendment and I-3 rezoning are needed to allow this City Park maintenance facility to continue to store fuel in above ground tanks. The building and facility are compatible with the scale and intensity of the surrounding park and residential land uses and do not adversely impact the area.

2. No other properties in the area would be rezoned for non-residential use.

3. I-3 zoning will permit the existing city park maintenance facility of the Wee Course to continue to store fuel in above ground tanks, as an incidental part of it's maintenance operation rather than having to spend public dollars to bury the fuel tanks that do not presently present a public safety issue.

#### THE EFFECTS OF THE PROPOSAL

1. Public water and sewer utilities are in place to serve the site.

2. The proposal will have no minimal impact on schools and no additional impact on the existing streets in the area.

3. The existing use will not change and will have a minimal impact on adjacent properties.

#### CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS

1. The City of Knoxville One Year Plan proposes low density residential use for this property, The amendment would change this area to LI (Light Industrial) consistent with the present maintenance use.
