Staff Recomm. (Full):	CB zoning at this location is an extension of zoning from the east, is compatible with surrounding land uses and zoning and is consistent with the sector plan proposal for the property.		
Comments:	 NEED BASED ON SUBSTANTIALLY CHANGED/CHANGING CONDITIONS IN THE AREA OR THE COUNTY GENERALLY: 1. Numerous properties fronting on Oak Ridge Hwy. in this area are developed with a range of commercial uses that are compatible with uses permitted in the CB zone. 2. The site is accessed from Oak Ridge Hwy., a major arterial street with sufficient capacity to support CB development. 3. A good portion of the surrounding area is already zoned for and developed with commercial uses. Some residential uses and zones are still in place along this section of Oak Ridge Hwy., but the sector plan proposes commercial uses for the properties that front on the highway. CONSISTENCY WITH INTENT AND PURPOSE OF THE ZONING ORDINANCE: 1. The requested CB zoning provides for a wide range of business and manufacturing uses. The nature of such businesses is to attract large volumes of automobile and truck traffic and have adverse effects on surrounding properties. Hence, they are not properly associated with, nor compatible with residential or institutional uses, or with other uses that require an environment free of noise, odors and 		
	 congestion. Based on the above description and intent of CB zoning, this property is appropriate to be rezoned to CB. THE EFFECTS OF THIS PROPOSAL Public water and sewer utilities are available in the area, but may have to be extended to serve the site. Establishment of CB zoning at this location would have little adverse impact on surrounding properties. CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS The Northwest County Sector Plan proposes commercial uses for the site, consistent with the requested CB zoning. The site is located within the Planned Growth Area on the Knoxville-Knox County-Farragut Growth Policy Plan map. Approval of this request may lead to future rezoning requests for CB zoning in the immediate area, on properties designated for commercial development on the sector plan.
