The applicant has proposed changing the name of this portion of Venice Road to Summer Bird Drive. Addressing staff has approved the proposed street name and all owners abutting the portion of Venice Road to be renamed have signed the petition in favor of the change. There are no properties using this portion of Venice Road for access, so no address changes would be required if the street name change is approved.
