Specifically, the request is for replacement signage on an existing yard sign and a building sign.</li> <li>The proposed building sign will be comprised of raceway mounted letters applied directly to the front wall of the building as it faces Lexington Drive. The size of the message area will be approximately 31 square feet. Since the building has a frontage of approximately 58 feet, the sign size is within the allowable range as required by the Design Guidelines. The letters will be white with a rainbow stripe underlining the letters. While the rainbow stripe exceeds the number of colors recommended under the Design Guidelines, it is allowed since it is a part of the corporate logo.</li> <li>The proposed sign area exceeds the allowable message area per sign face based on the building frontage, waivers were granted for this sign by the Board when the sign was approved for Abra Auto Body &amp; Glass on August 11, 2014. The sign will include white letters on a black background with the rainbow stripe placed between the words Caliber and Collision.</li> </ol>
