Staff has heard opposition to the closure from a citizen who reports that trucks use the alley and exit to Western Ave. through the private parking lot within which this subject right-of-way is located. However, any vehicular access through the parking lot will be subject to permission by the owner of the property, which is no different than the existing situation.
