Staff Recomm. (Full): 1. This right-of-way closure will not be effective until all buildings accessed from this section of Bonnyman Dr. have been razed.
2. Obtaining any required easements.

With the above condition included, staff has received no objections to this closure. The applicant owns all the property adjacent to this right-of-way.

Comments: The applicant owns all of the property adjacent to this public street and, if closed, intends to incorporate the right-of-way into the rest of the private property on either side. The recommended conditions will insure that this does not occur until the buildings accessed from the subject street have been torn down. The following condition allows emergency services, specifically the fire department, to access that area, should an emergency arise within the existing buildings along this section of Bonnyman Dr.

1. This right-of-way closure will not be effective until all buildings accessed from this section of Bonnyman Dr. have been razed.
2. Obtaining any required easements.
