Comments:	 NEED AND JUSTIFICATION FOR THE PROPOSAL The site is located at the edge of an area which has been developed with many warehouse and manufacturing uses, consistent with uses permitted under I-3 zoning. The Northwest County Sector Plan proposes industrial uses on the properties directly adjacent to this site to the east, so this proposal would be an extension of the industrial designation to the west. I-3 zoning is compatible with the scale and intensity of the surrounding land uses and zoning pattern. 				
	 THE EFFECTS OF THE PROPOSAL Public water and sewer utilities are available to serve the site. The change in zoning will have minimal impact on streets and no impact on schools. Uses permitted under I-3 zoning are compatible with the surrounding development in the area. 				
	 CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS 1. The Northwest County Sector Plan proposes commercial uses for this site, but it is an extension of the industrial designation directly from the east. 2. The site is located within the Planned Growth Area of the Knoxville-Knox County-Farragut Growth Policy Plan. 3. The City of Knoxville One Year Plan proposes GC (General Commercial) uses for this site, which does not allow I-3 zoning. MPC staff has agreed to update the plan designation accordingly as part of the 2004 One Year Plan update, which is currently underway and will be considered by MPC at the March 11, 2004 meeting. 4. Since the subject property is located within the TO-1 (Technology Overlay), a Certificate of Appropriateness from the Tennessee Technolgy Corridor Development Authority (TTCDA) will also be required for this rezoning request. This item will be considered by TTCDA on March 8, 2004.
