The sector plan proposes low density residential use and slope protection for this site.		
Comments:	EED AND JUSTIFICATION FOR THE PROPOSAL The property has an illegal auto repair business and needs a commercial designation to seek CA oning. The site is not shown as commercial by the sector plan. The applicant's request will allow this te to be zoned CA commercial which is contrary with the established low density residential uses and A zoning of surrounding properties. A Commercial designation and CA zoning would permit a range of commercial uses incompatible ith other uses in the area and the slope constraints of the northern part of the site. The applicant mould locate his business in an area appropriate for commercial development.		
	 THE EFFECTS OF THE PROPOSAL Public water is available to serve the site, while sewer is not available. Commercial development of this site will impact Mynatt Rd. with additional traffic and turning movements in this area, but it will have no impact on schools. CA zoning allows uses that are incompatible with surrounding residential zoning and uses. 		
	 CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS 1. The Sector Plan proposes low density residential uses and slope protection for this site and the adjoining area. 2. The site is located within the Planned Growth Area of the Knoxville-Knox County-Farragut Growth Policy Plan. 3. This request could lead to similar plan amendment requests in the future for other properties along Mynatt Rd.
