### MPC ACTION AND DISPOSITION

Staff Recomm. (Full): Mixed use commercial, light industrial and office uses are compatible with surrounding development

and zoning. The sector plan proposes light industrial use for the site.

Comments: NEED AND JUSTIFICATION FOR THE PROPOSAL

1. The surrounding properties are zoned I-3, C-3 and R-2 and developed with light industrial, commercial and related uses between Western Ave., and Middlebrook Pike. The C-3 zoning will allow this site to be developed with a medical office and have two wall signs on the property.

- 2. C-3 zoning is compatible with the surrounding I-3, I-2, C-4 and C-3 zoning and development pattern.
- 3. Development permitted under C-3 zoning is compatible with the light industrial and commercial uses on the surrounding properties.

#### THE EFFECTS OF THE PROPOSAL

- 1. Public water and sewer utilities are available to serve the site.
- 2. The proposal will have a minimal impact on streets and no impact on schools.
- 3. The proposal is compatible with surrounding land uses and zoning and will have minimal impact on adjacent properties.

#### CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS

- 1. The Sector Plan proposes light industrial use for this site. The requested Mixed Use One Year Plan amendment will permit C-3 as one of the appropriate zones.
- 2. The site is located within the Urban Growth Area (Inside the City) of the Knoxville-Knox County-Farragut Growth Policy Plan.

If approved, this item will be forwarded to Knoxville City Council for action on May 11 and 25, 2004. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.
