The proposed ordinance would not be part of the Zoning Ordinance; if adopted it would be codified in Chapter 16 of the City of Knoxville Code of Ordinances. STR's would be permitted in all zoning districts by the proposed ordinance, but would be limited to owner-occupied residences in the residential zoning districts.
