Comments: 1) This is a request for approval of a change in a business building sign at this existing strip

commercial center at the northeast corner of the intersection of Hardin Valley Road and Charlevoix

Road east of Pellissippi Parkway.

2) The proposed building sign includes the business name for Don Gallo Restaurant and replaces the

restaurant's existing sign. The sign will be located above the awning canopied entrance to the

business.

3) The new sign consists of raceway-mounted channel letters mounted directly to the building. The letters have plexiglass faces, are internally illuminated with LED lighting, and have a matte finish.

4) The sign comprises an area of approximately 35 square feet, which is within the limits allowed for

this business based on the 47 feet of building frontage which yields a maximum sign area of 47 square

feet.
