Staff Recomm. (Full): C-4 zoning is consistent with surrounding commercial zoning and development. The sector plan and One Year Plan propose commercial use for this site.

Comments: NEED AND JUSTIFICATION FOR THE PROPOSAL
1. C-4 zoning is compatible with the scale and intensity of the surrounding development and zoning pattern.
2. C-4 is a logical extension of zoning from the northwest.
3. The C-4 zoning, as proposed, will allow outside display of furniture on this property.

THE EFFECTS OF THE PROPOSAL
1. Public water and sewer utilities are in place to serve the site.
2. This proposal will have no impact on schools and minimal impact on the street system.
3. The proposal is compatible with the surrounding zoning, and the impact on adjacent properties will be minimal.

CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS
1. The Central City Sector Plan proposes commercial uses for the site, consistent with C-4 zoning.
2. The site is located within the Urban Growth Area (inside city) of Knoxville on the Knoxville-Knox County-Farragut Growth Policy Plan map.
3. This request may generate similar requests for C-4 zoning on surrounding parcels, as other area properties with frontage on N. Central St. are already zoned C-4 commercial.
