1) Meeting all relevant requirements of the Knoxville Zoning Ordinance, as appropriate.

1) This is a request for two new building signs and change out the sign panel for an existing yard sign

for Lincoln Memorial University and DeBusk College of Osteopathic Medicine.

2) The new building signs will include a sign for Lincoln Memorial University (LMU) and a sign for

DeBusk College of Osteopathic Medicine.

3) The sign for LMU will be located above the upper windows of the front façade of the building on the southern wing of the building. That portion of the building has a frontage of 175' which will allow a building sign of up to 100 square feet. The proposed sign has an area of 100 square. The aluminum reverse channel letters will have LED halo lighting.

4) The sign for DeBusk College of Osteopathic Medicine will be located above the upper windows of the front facade of the building on the northern wing of the building. That portion of the building has a frontage of 175' which will allow a building sign of up to 100 square feet. The proposed sign has an

area of 90 square. The aluminum reverse channel letters will have no lighting.

5) The sign panel on the existing yard sign will also be modified to identify this site as the Campus for both Lincoln Memorial University and DeBusk College of Osteopathic Medicine. The total sign area for the proposed lettering is approximately 56 square feet. The maximum sign area allowed for the one

sided sign is 100 square feet. The aluminum reverse channel letters will have no lighting.
