Staff Recomm. (Full): Based on the application and sign plans as submitted, staff recommends APPROVAL of a Certificate of Appropriateness for a sign permit, subject to the following condition:

1) Meeting all relevant requirements of the Knox County Zoning Ordinance, as appropriate.

Comments:

1) This is a request for two building signs at 10620 Kemp Fain Lane. The building formerly housed Brinks Home Security Systems, and building plans were approved by the TTCTA in 2005. The applicant will use the existing building and site as is. The building fronts Kemp Fain Lane, but the side of the building is visible from Cherahala Boulevard to the south. The signage is for ADT Security Systems.

2) The building frontage is approximately 238 linear feet, so 100 square feet is the maximum square footage allowed for building signage.

3) There are two signs proposed for the building; one will face Kemp Fain Lane and the other will face Cherahala Boulevard. Both signs are identical in design. They comprise 49 square feet each, for a total area of 98 square feet.

4) Each sign will be a 5" deep illuminated channel logo cabinet. The sign plans denote lexan panels for the flex face sign directly mounted to the building façade and internally lit with LED lighting.

5) The sign will be blue and white, utilizing the blue of the ADT logo.
