This is the same model car that Knox County Sheriff uses for administrative purposes. MPC originally planned to purchase a smaller vehicle for around \$13,000 from the new Tennessee statewide contracts that may become available in October, 2007. The MPC FY07/08 budget line item 9200110-9650 Vehicle was approved for \$15,000 and requires a line item transfer to cover the extra cost. The budget transfer has been made from 9200110-9250 Auto Allowance. | | |
| | The MPC currently owns three vehicles: 1995 Dodge Dakota truck with 79,000 miles (general staff use); 1996 Chevrolet S-10 truck with 203,000 miles (assigned to Allen Alderman); 2000 Jeep Cherokee with 67,000 miles (general staff use); all valued less than \$10,000 cumulatively. MPC plans to keep the current vehicles except, perhaps, for the 1995 Dodge truck which was used to haul traffic counting equipment and is no longer used much. An analysis on whether to surplus this vehicle will be made soon. The requested purchase of a four door sedan is needed primarily for general staff traveling to local and regional meetings. The vehicles are regularly maintained by Knox County Fleet Service at an average annual cost of | | |
