**Staff Recomm. (Full):**

PR at the requested density is compatible with surrounding residential development in the area and is a contiguous addition to the previously approved PR zoning to the south and west.

**Comments:**

NEED AND JUSTIFICATION FOR THE PROPOSAL

1. Other properties in the immediate area are developed with residential uses under A, RA and PR zoning.
2. PR zoning at 1 to 4 du/ac is compatible with the scale and intensity of the surrounding development and zoning pattern. The subject property will be combined with the adjacent property, already approved for PR zoning, for one development.
3. PR zoning will require MPC use on review approval of site plans prior to any development of the property. During this review, potential issues such as traffic, drainage, access, topography, lot layout and other development concerns can be addressed.

THE EFFECTS OF THE PROPOSAL

1. Public water and sewer utilities are available in the area to serve the site.
2. The subject property is proposed to be developed with the adjacent site, which was approved for PR by MPC on Feb. 10, 2005. At the proposed density, 4 additional dwelling units could be proposed for the entire PR zoned site. The development of single family detached dwellings would add approximately 40 more vehicle trips per day to the street system and about 3 more children under the age of 18 to the school system.
3. If more than 75 lots are being proposed as part of the overall development, a traffic impact study will be required to be submitted with concept/use on review plans.
4. The proposal is compatible with the surrounding zoning, and the impact on adjacent properties will be minimized during the use on review/concept plan process.

CONFORMITY OF THE PROPOSAL TO ADOPTED PLANS

1. The Southwest County Sector Plan proposes low density residential uses for the site, consistent with this proposal.
2. The site is located within the Planned Growth Area on the Knoxville-Knox County-Farragut Growth Policy Plan map.
3. This request may generate similar requests for PR zoning in this area in the future on surrounding properties that are proposed for low density residential uses by the sector plan.

Upon final approval of the rezoning, the developer will be required to submit a concept plan/use on review development plan prior to the property's development. The plan will show the property's proposed lot pattern and street network and will also identify the types of residential units that may be constructed. Grading and drainage plans may also be required at this stage, if deemed necessary by Knox County Engineering and MPC staff.
